

**DHL ULTIMATE SMALL BUSINESS INDYCAR
SWEEPSTAKES
OFFICIAL SWEEPSTAKE RULES (the "OFFICIAL RULES")**

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR TO WIN THIS SWEEPSTAKE. A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING. THIS SWEEPSTAKE IS OPEN TO LEGAL RESIDENTS OF THE CONTIGUOUS UNITED STATES OF AMERICA ONLY, AND IS GOVERNED BY THE LAWS AND REGULATIONS OF THE FEDERAL GOVERNMENT AND THE STATE OF FLORIDA AND IS VOID WHERE PROHIBITED BY LAW. ONE MUST OWN OR MANAGE A SMALL BUSINESS OPERATING WITHIN THE UNITED STATES TO PARTICIPATE. PARTICIPATION IN THIS SWEEPSTAKE CONSTITUTES FULL AND UNCONDITIONAL AGREEMENT WITH AND ACCEPTANCE OF THESE OFFICIAL RULES.

1. **ELIGIBILITY:** The DHL Ultimate Small Business IndyCar Sweepstakes ("**Sweepstake**") is open to legal residents of the contiguous United States, who at the time of entry are independent owners and the authorized agent of an eligible for-profit small business (as defined below) in their state of residence and are at least the age of eighteen (18). You are not eligible to enter if you are an officer, director, employee, agent, or representative of, or a member of the immediate family (defined as parent, sibling, children and/or spouse and regardless of where they live) of, or domiciled with (whether related or not) any such officer, director, employee, agent or representative of DHL Express (USA), Inc. The Sponsor, its advertising and promotional agencies, any independent contest judging organization, the parent, subsidiary, affiliate and related entities of each of the foregoing and all of their respective officers, directors, owners, employees, agents, representatives, successors and assigns shall be referred to herein as the "**Sweepstake Entities**".

In order to be considered eligible as a "small business" for purposes of this Sweepstake (each, an "**Entrant**"), the business must meet the following criteria:

- Business is based, registered and operating in the United States;
- Currently active, lawful, and have all necessary and required licenses and registrations as per the laws of the state of organization;
- In continuous operations for not less than one (1) year as of January 1, 2026;
- In good standing as of the date of submission of an Entry, as defined below, and must remain so through the end of the Sweepstake Period, as defined below; and
- Have a minimum of ten (10) and no more than one hundred (100) employees on its payroll at the time of submission of an Entry (sole proprietors are considered as an employee and part-time employees are included).

But the following are excluded:

- Business is in any way affiliated with a franchised or direct seller business, whether registered in or outside of the United States;
- Business is a non-profit organization as defined under the laws of the state of organization;
- Primary purpose of the business is in competition with DHL or any DHL operating companies;
- Business is in competition with or has a conflict of interest with Chip Ganassi Racing, LLC, Chip Ganassi Racing Teams, LLC, Alex Palou and/or Car #10 in the INDYCAR Series, and their respective sponsors;
- Business is directly or indirectly involved in the production, distribution, or sale of illegal drugs, controlled substances, or any products or services that violate applicable drug laws;
- Business is engaged in offering products or services involving pornography, sexually explicit content, or any form of morally indecent activities as determined at the sole discretion of the Sponsor; or
- Business is under bankruptcy protection under any bankruptcy laws.

Upon request by Sponsor, an Entrant must provide proof of their identity and qualification under the above eligibility criteria. Sponsor shall determine, in its sole discretion, whether an Entrant meets the eligibility criteria to participate in the Sweepstake. Sponsor's decisions regarding eligibility and all other aspects of the Sweepstake are final and binding.

To be eligible, Entries (defined below) must be received by Sponsor during the Sweepstake Period. Proof of Entry submission does not constitute proof of receipt by Sponsor.

Once completed, click “submit” and you will receive one (1) entry into the Sweepstake (each an “**Entry**” or collectively, “**Entries**”). All fields on the Entry Form must be completed unless indicated as optional. Limit of one (1) Entry per person or entity and per email address during the Sweepstake Period. Each Entry must be submitted by the Entrant’s authorized representative. The Sponsor’s clock is the official time-keeping device to determine date and time of Entry. Entrants are responsible for providing their own correct contact data. All Entries are subject to verification at any time and for any reason.

All Entries that are incomplete, illegible, damaged, irregular, have been submitted through illicit means, using any robotic, automatic programmed method that artificially increases the odds of winning or do not conform to or satisfy any condition of these Official Rules may be disqualified by the Sponsor. Sponsor is not responsible for any errors or omissions in printing and advertising this Sweepstake.

Sponsor reserves the right to reject featuring any logo that, in its sole discretion, it deems obscene, offensive, illegal or in conflict with its business or that of its affiliates;
- (2) Two passes to the Borchetta Bourbon Music City Grand Prix race weekend, which includes two single-event credentials, hospitality and a meet and greet opportunity with the No. 10 No. 10 DHL Chip Ganassi Racing driver, Alex Palou. Estimated value of USD \$1,000. Winner is responsible for all travel and accommodations to the event.

- 5. DRAWING AND NOTIFICATION:** One Winner will be selected in a random draw to be held between Monday, June 1, 2026 and Friday, June 5, 2026 (the “**Draw Period**”), from all eligible Entries received during the Sweepstake Period. The odds of being selected as eligible to win the Grand Prize will depend upon the total number of eligible Entries received during the Sweepstake Period.
- 6. WINNER SELECTION:** The selected winner will be notified between Wednesday, June 3, 2026 and Monday, June 8, 2026 by email provided by the Entrants at the time of Sweepstake submission. Please check your email and spam filters.

Communication will be entered into only with the selected winner. Before being declared a winner, the selected winner will be required to complete and return to Sponsor by the deadline communicated to winner a written Declaration of Compliance and a Liability and Publicity Release (the “**Declaration and Release**”), which, among other things: (a) confirms compliance with these Official Rules; (b) acknowledges acceptance of the Grand Prize

- 9. INDEMNIFICATION:** By submitting an Entry into this Sweepstake, each Entrant confirms his or her understanding of and compliance with these Official Rules. Each Entrant, and their representatives, heirs, next of kin or assignees ("Entrant's Representatives"), hereby releases and holds the Sweepstake Entities and Chip Ganassi Racing, LLC and Chip Ganassi Racing Teams, LLC and any companies affiliated with them, and any companies affiliated with Alex Palou and/or Car #10 in the INDYCAR Series (collectively "**Indemnified Parties**") harmless from any and all liability for any injuries, loss or damage of any kind to the Entrant, Sweepstake Entities or any other person, including personal injury, death or property damage, resulting in whole or in part, directly or indirectly, from acceptance, possession, use or misuse of the prizes, participation in the Sweepstake, any breach of the Official Rules, or in any prize-related activity. LIMITATIONS OF LIABILITY AND RELEASES:** BY PARTICIPATING IN THIS SWEEPSTAKE, ENTRANTS AGREE THAT SWEEPSTAKE ENTITIES AND INDEMNIFIED PARTIES HAVE NO LIABILITY WHATSOEVER FOR, AND SHALL BE HELD HARMLESS BY ENTRANTS AGAINST ANY LIABILITY FOR ANY INJURIES, LOSSES OR DAMAGES OF ANY KIND (INCLUDING DIRECT, INDIRECT, INCIDENTAL, CONSEQUENTIAL OR PUNITIVE DAMAGES) TO PERSONS OR PROPERTY, INCLUDING WITHOUT LIMITATION, RESULTING FROM: A) ENTRY OR PARTICIPATION IN THIS SWEEPSTAKE OR ANY SWEEPSTAKE-RELATED ACTIVITY, INCLUDING ACCESS TO AND USE OF THE SWEEPSTAKE WEBSITE, OR B) ANY CLAIMS BASED ON PERSONALITY OR PRIVACY RIGHTS, DEFAMATION OR MERCHANDISE DELIVERY OR C) AWARDED, RECEIPT, POSSESSION, USE OR MISUSE OF ANY PRIZES. If any provision of the Official Rules is determined to be invalid or otherwise unenforceable, then the Official Rules shall be construed in accordance with their terms as if the invalid or unenforceable provision was not contained therein. Should a prize winner make any false statement(s) in any document referenced above, the prize winner will be required to promptly return to Sponsor or relinquish the Grand Prize, as the case may be, or the cash value thereof.

12. GOVERNING LAW: The Sweepstake shall be governed by federal law and the laws of the state of Florida. Without limiting the generality of the foregoing, all issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules or the rights and obligations as between any person and/or Entrant and the Sweepstake Sponsor in connection with the Sweepstake shall be governed by and construed and interpreted in accordance with, including the procedural provisions of those laws, without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other jurisdiction's laws. The Sweepstake Sponsor and all Entrants hereby submit to the jurisdiction of the courts of the federal government and the state of Florida; in respect of the determination of any matter, issue or dispute arising under or in respect of these Official Rules and/or the Sweepstake and agree that any such determination shall be brought solely and exclusively before such courts.

The invalidity or unenforceability of any provision of these Official Rules shall not affect the validity or enforceability of any other provision. In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these Official Rules shall otherwise remain in effect and shall be construed in accordance with the terms as if the invalid or illegal provision were not contained herein.
