Internet access and the Formula 1® 2020 or 2021 game required for online submissions. **To Enter:** Visit [InMotion.dhl/VirtualFastestLap](https://InMotion.dhl/VirtualFastestLap) and register your contact details as per the entry form provided. Record and submit your fastest lap of the nominated circuit on the F1® 2020 or 2021 game. **Competition Fulfilment:** 2 entrants with the independently adjudicated fastest lap times for each entry window and respectively, on each version of the game will win the prize. Laps will be judged to ensure no fraudulent laps (cutting corners, using glitches, etc.) have been submitted. **Prize:** A place in the F1® Esports Series 2023 DHL Time Trial and a Fanatec voucher valued at €1,000 and the 2022 Formula 1 Game. **Promoter:** Deutsche Post AG ("DHL")

#### 7. Upload Settings:

- a) Gamertag and live timing need to be viewable during the entirety of the lap
- b) Lap time must be viewable at the end of the lap
- c) It is not permitted to record the in-game replay of the lap
- d) Recordings should be made in a 1920 x 1080 59.94fps - H264 (mp4) format
- e) Recordings should contain track audio only with no comments or talking

8. Multiple entries of the same email address cannot and will not be accepted.

9. All registrations must be received by the end of the relevant Promotion Period to be valid and no liability is accepted for incomplete or late entries.

#### 10. Competition Fulfilment:

Per each entry window, the entrant with the independently adjudicated fastest lap on PlayStation, Xbox & PC will win the prize. Laps will be judged to ensure no fraudulent laps (cutting corners, using glitches, etc.) have been submitted. In the event that there is a tie for the fastest lap set, the entrant who uploaded their lap first will win. Once the winners have been selected, and their email address provided in the contact details has been confirmed, DHL will contact the winners directly to inform them they have won. The winners will have 7 days to accept their prize before an alternative winner is selected. Announced winners from previous rounds cannot participate in other rounds.
