Backyard Mechanic- Terms and Conditions

Full Terms and Conditions

1. This Promotion is only open to those aged 18 or over, including employees and customers of the Promoter, but excluding their agents or anyone else professionally connected with this Promotion.
2. Entrants must ensure that their participation (including the acceptance of any prize awarded) is lawful in accordance with the laws of the country of which they are a citizen and/or resides. This Promotion is void where void under local national laws. The Promoter shall not be taken to make any representations, express or implied, as to the lawfulness of any individual's participation, or as to any other aspect of any Promotion.
3. Purchase is not necessary, but internet access and a valid email address is required.

 - Are you working on your bike, or helping a friend make changes to theirs? Tell us how you're improving the bike to make it a better ride! (250 words max)
 - How could you make the bike even better? (100 words max)Finally, provide an image (max 10MB) or video (max 50MB) of your bike and any modifications you have already made, in order to complete your entry.
6. Entrants can enter only once during the Promotion Period.
7. **The Prize:** One winner will receive a MotoGP™ bike part upgrade, up to the value of €1,500. We will identify the appropriate supplier and part based upon the winning entry's bike brand, model, age and requirements.
8. **Further Prize Details:**
 - a. The prize is non-refundable and non-transferable.
 - b. For the avoidance of doubt, the prize does not include any mechanical costs required to fit the bike part or any other costs of a personal nature (including spending money) that are not explicitly set out in these terms and conditions, and neither the Promoter nor the provider of any part of the prize will be responsible for any such costs.
 - c. The promoter and provider of the part are not responsible for any maintenance, servicing, or repairs to the prize winners bike or the part provided.
 - d. The winner is solely responsible for any additional costs incurred fitting the bike part, including mechanical costs, fuel, provision of tools.
9. **Winner Selection:** All valid entries received by the Promoter during the Promotion Period will be entered into a prize draw to select 100 longlisted entries within 3 working days of the close of the Promotion Period by PromoVeritas. All longlisted entries will be judged to a shortlist of 10

entries by PromoVeritas, within 4 working days of the end of the Promotion Period and in accordance with the following criteria:

- a. Unique/Original - Does the entry stand out of from other entries?
- b. Impressive/Innovative - Is the entry impressive and/or does it showcase innovation to the reader?
- c. Realistic - Are the suggested bike modifications achievable within the promoters EUR 1500 budget?

The Promoter and PromoVeritas will then select the winner from the 10 shortlisted entries within 5 working days of the end of the Promotional Period based on the same criteria.

10. **Winner Notification:** The winner will be contacted via the email address and or phone number provided upon entry within 10 working days of judging and will be required to respond to confirm eligibility plus acceptance of the prize within 5 days of initial contact. In the event that the winner does not respond to communications within 5 days of initial contact, the Promoter reserves the right to disqualify the winner. In the event that the winner is disqualified, the Promoter reserves the right to allocate the prize to an alternative winner selected in the same manner.
